Centrica plc announces that it purchased on 28 February 2025 (through Goldman Sachs International) 881,210 Centrica plc ordinary shares of $6^{\,14}/_{81}$ pence each at a price of 148.6977 pence per share. The purchased shares will be held as treasury shares. Such purchase was effected pursuant to the Company's buyback programme announced on 8 August 2024 and in accordance with the non-discretionary share repurchase agreement entered into with Goldman Sachs International and pursuant to the Company's buyback programme update announced on 27 December 2024 and in accordance with the separate non-discretionary agreement with Goldman Sachs International.

Since 8 August 2024, Centrica has purchased 181,529,791 ordinary shares at a cost (excluding dealing and associated costs) of £229,999,333.99.

Following the above purchase, Centrica plc holds 450,108,850 ordinary shares in treasury, and has 5,042,998,364 ordinary shares in issue (excluding treasury shares).
