Centrica plc announces that it purchased on 4 March 2025 (through Merrill Lynch International) 1,865,096 Centrica plc ordinary shares of 6 $^{14}/_{81}$ pence each at a price of 146.86 pence per share. The purchased shares will be held as treasury shares. Such purchase was effected pursuant to the extension of the Company's 2024-25 buyback programme announced on 27 December 2024 and in accordance with the non-discretionary share repurchase agreement entered into with Merrill Lynch International as also announced on 27 December 2024, which agreement was subsequently amended as announced on 3 March 2025.

Since 3 March 2025, Centrica has purchased 6,061,591 ordinary shares at a cost (excluding dealing and associated costs) of £8,993,536.13.

Following the above purchase, Centrica plc holds 456,170,441 ordinary shares in treasury, and has 5,036,936,773 ordinary shares in issue (excluding treasury shares).
