Amedeo Air Four Plus Limited (the "**Company**") is a Guernsey domiciled company with shares admitted to trading on the Specialist Fund Segment of the London Stock Exchange's Main Market.

AA4P Beta (MSN164) Redelivery Condition Side Letter

The Company, via its wholly owned subsidiary AA4P Beta Limited (the "**Subsidiary**") has received a notice from Emirates in respect of MSN 164 (registration A6-EOB, the "**Aircraft**") exercising the "half-life" option for a potential aircraft return. The option provides for a cash sum that Emirates will pay as a part of the monetary compensation arrangements where the final monetary payment will be based on the actual physical condition of the aircraft vs half-life condition. The lease expiry date for MSN 164 is 3 November 2026.

The Board notes that the above does not preclude the Company from considering lease extension, sale or re-lease options for the Aircraft with Emirates or other counterparties.
