Application will be made for the Repurchased Shares to be cancelled. Following the cancellation of the Repurchased Shares, the total number of ordinary shares with voting rights will be 329,916,763 which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Vertu Motors under the FCA's Disclosure Guidance and Transparency Rules. The Company holds no shares in treasury.

Since the Group began Share Buybacks in October 2018, over £35.8m has been returned to shareholders, reducing the Company's shares in issue by 17.0% over the same period.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
