**2025 Long Term Incentive Plan and Grant of Options to PDMRs**

RHI Magnesita announces the granting of awards under the RHI Magnesita Long Term Incentive Plan ("LTIP"), to a number of persons discharging management responsibilities ("PDMRs").

The price used to calculate the maximum number of ordinary shares under the LTIP was £33.88, being the average closing price on 27<sup>th</sup> and 28<sup>th</sup> February, and 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> March 2025 of the Company's shares on the main market of the London Stock Exchange.
