The Ordinary Shares purchased form part of Keny's intention to buyback Ordinary Shares of a total value of up to €300 million in the period up to 30 June 2025 ("**Buyback Programme**"). The intention to launch this Buyback Programme was announced on 24 October 2024 and formally commenced on 12 November 2024.

Following settlement of the above transactions and subsequent share cancellation Kerry will have 165,646,057 Ordinary Shares in issue (excluding treasury shares).
