### QinetiQ Group plc Transaction in own shares

QinetiQ Group plc (the **Company**) announces that on 10 March 2025 it has purchased, in accordance with the authority granted by shareholders at the annual general meeting of the Company held on 18 July 2024, the following number of its ordinary shares of 1 pence each (**Shares**) on the London Stock Exchange pursuant to the Third Tranche of its existing share buyback programme, the commencement of which was announced on 3 February 2025.

The Company intends to cancel the purchased shares.
