Therefore, the total number of ordinary shares with voting rights in the Company is 201,560,900 ordinary shares.

The above figure of 201,560,900 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure and Transparency Rules.
