Such purchase was effected pursuant to the extension of the Company's 2024-25 buyback programme announced on 27 December 2024 and in accordance with the non-discretionary share repurchase agreement entered into with Merrill Lynch International as also announced on 27 December 2024, which agreement was subsequently amended as announced on 3 March 2025.

Since 3 March 2025, Centrica has purchased 11,942,826 ordinary shares at a cost (excluding dealing and associated costs) of £17,563,746.27.

Following the above purchase, Centrica plc holds 462,006,353 ordinary shares in treasury, and has 5,031,100,861 ordinary shares in issue (excluding treasury shares).
