Share Buyback Programme

As part of Informa's Capital Allocation programme, the Company has a commitment to delivering consistent shareholder returns, including through share buybacks. In 2025, the Company has committed a minimum of £200m to its share buyback programme.

On 18 March 2025, the Company purchased 323,694 ordinary shares for cancellation through Morgan Stanley & Co. International plc at an average price of 772.25 pence per share. The highest and lowest purchase price paid per share were 776.80 and 768.80 respectively, with the aggregate details of shares purchased by trading venue as outlined in the table below:
