**Deliveroo plc ("Deliveroo" or "the Company")
Transactions in own shares**

Deliveroo announces that it has purchased 1,310,982 Ordinary Shares of £0.005 each (the "Shares") in the Company, through Goldman Sachs International ("GSI") on the London Stock Exchange, BXE and CXE order books, and/or Turquoise (the "Purchase").

The Purchase was effected pursuant to Deliveroo's share purchase programme, details of which were announced on 9 August 2024.

Volume weighted average price paid per share:	1.2335

It is intended that the purchased Shares will be cancelled.

A full breakdown of the individual purchases by GSI (acting as principal) is included below, which were subsequently repurchased from GSI by the Company.

Following the above transaction the Company's issued share capital is 1,566,668,921 Ordinary Shares of £0.005 (including 50,713,918 Ordinary Shares held in treasury).

The total number of voting rights attributable to the Ordinary Shares is therefore 1,515,955,003 (excluding 50,713,918 Ordinary Shares held in treasury) and may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Ordinary Shares under the FCA's Disclosure Guidance and Transparency Rules.
