As part of Informa's Capital Allocation programme, the Company has a commitment to delivering consistent shareholder returns, including through share buybacks. In 2025, the Company has committed a minimum of £200m to its share buyback programme.

On 26 March 2025, the Company purchased 310,582 ordinary shares for cancellation through Morgan Stanley & Co. International plc at an average price of 804.94 pence per share. The highest and lowest purchase price paid per share were 808.00 and 801.60 respectively, with the aggregate details of shares purchased by trading venue as outlined in the table below:
