

Banco Santander, S.A. (the "**Bank**" or "**Banco Santander**"), in compliance with the Securities Market legislation, hereby communicates the following:

OTHER RELEVANT INFORMATION

Reference is made to our notice of inside information of 5 February 2025 (official registry number 2584) (the "**Buy-back Commencement Communication**"), relating to the buyback programme of own shares (the "**Buy-back Programme**") approved by the Board of Directors of Banco Santander.

Pursuant to article 5 of Regulation (EU) no. 596/2014 on Market Abuse of 16 April 2014, and articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, the Bank informs of the transactions carried out over its own shares between 20 and 26 March 2025 (both inclusive).

The cash amount of the shares purchased to 26 March 2025 as a result of the execution of the Buy-back Programme amounts to 573,513,880 Euros, which represents approximately 36.1% of the maximum investment amount of the Buy-back Programme. The programme was announced together with its other characteristics through the Buy-back Commencement Communication. With these purchases, the Bank has repurchased approximately 13.2% of its outstanding shares as of 2021.
