The actual number of shares which vest will depend on the extent to which the relevant performance conditions have been satisfied.

The performance conditions applicable to the LTIP Awards will be based as follows:

- 20% on relative total shareholder return (TSR) performance;
- 35% on ROCE performance;
- 15% on Hospital EBIT Margin performance; and
- 30% on two Operational Excellence measures.

Further details of these performance conditions will be disclosed in the 2024 Annual Report and Accounts when published.

The share price used to determine the number of shares under the LTIP Awards was 174.04 pence being the average of the mid-market closing share price over the five trading days ending on 26 March 2025.

The transaction place is London.
