The Company announces that on 7 April 2025 it purchased 370,000 ordinary shares of 1 pence each ("Ordinary Shares") at a price of 32.75 pence per Ordinary Share from its corporate broker, Panmure Liberum Limited ("Panmure Liberum"), in accordance with the terms of its share buyback programme announced on 16 January 2025 (the "Share Buyback Programme").

Following settlement of the Ordinary Shares purchased above, the Company will have 179,369,199 Ordinary Shares in issue, each with one voting right, and 5,989,685 Ordinary Shares held in treasury.

The total number of voting rights in the Company will therefore be 173,379,514. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
