GCP Infra today announces that pursuant to the general authority granted by shareholders of the Company at the annual general meeting on 13 February 2025 to make market purchases of its own ordinary shares, it repurchased 200,000 ordinary shares at a weighted average price of 71.02 pence per share, to be held in treasury, on 08 April 2025.

Following this transaction, the Company has in issue 884,797,669 ordinary shares of which 33,152,688 are held in treasury.

For reporting purposes under the FCA's Disclosure Guidance and Transparency Rules the market should exclude any shares held in treasury and should use the figure of 851,644,981 voting rights when determining if they are required to notify their interest in, or a change to their interest in the Company.
