Offer for Subscription - Update

On 24 September 2024 Puma VCT 13 plc (the "Company") published a prospectus in relation to an offer for subscription for new ordinary shares of £0.0005 each in the Company to raise up to £50 million, with an over-allotment facility which has been exercised to raise up to a further £20 million (the "Offer").

Having raised gross proceeds of more than £55 million as of 4 April 2025, the Company announces that the Offer will be closed to further applications at 5.00 pm on 7 May 2025 with the final allotment expected to take place during the week commencing 12 May 2025 and admission expected to take place within two business days of such allotment. The closing date may be brought forward at the Directors' discretion by way of an announcement.
