The Purchase was effected pursuant to Deliveroo's share purchase programme, details of which were announced on 9 August 2024, and subsequently on 18 March 2025.

The total number of voting rights attributable to the Ordinary Shares is therefore 1,497,888,412 (excluding 12,548,656 Ordinary Shares held in treasury) and may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Ordinary Shares under the FCA's Disclosure Guidance and Transparency Rules.
