## Informa Share Buyback Programme

Update on shareholder returns

Informa PLC ('the Company') (LSE: INFL), the international B2B Events, B2B Digital Services and Academic Markets Group today provided an update on its share buyback programme

## Share Buyback Programme

As part of Informa's Capital Allocation programme, the Company has a commitment to delivering consistent shareholder returns, including through share buybacks. In 2025, the Company has committed a minimum of £200m to its share buyback programme.

On 29 April 2025, the Company purchased 485,800 ordinary shares for cancellation through Numis Securities Limited ("Deutsche Numis") at an average price of 720.13 pence per share. The highest and lowest purchase price paid per share were 722.40 and 715.20 respectively, with the aggregate details of shares purchased by trading venue as outlined in the table below:
