Following this, the total number of treasury shares held by the Company is 7,372,957 USD Shares and the number of shares in issue less those shares held in treasury is 137,472,326 USD Shares.

From 30 April 2025, the total number of voting rights in the Company is 137,472,326. This figure may be used by shareholders as the denominator for calculations to determine if they are required to notify their interest in, or a change to their interest in, the Company, under the FCA Disclosure Guidance and Transparency Rules.
