"David has provided great service and support to the Board during his tenure at Jupiter, first as chair of the Audit and Risk Committee and latterly as our Board Chair, and we thank him for all his efforts. Under David's leadership, we have made significant strategic progress and we are focused on appointing a successor who can continue to build on this momentum."

#### Matthew Beesley, Chief Executive Officer, said:

"I and my fellow Board members thank David for his guidance and support through the last four years and wish him well with his other commitments. He leaves Jupiter and the Board well positioned to take advantage of the opportunities that lie ahead."
