1. The Company's issued share capital as at close of business on 30 April 2025 consisted of 3,670,529,876 ordinary shares of USD 0.50 per share ("Ordinary Shares"), each with one vote, including 7,489,044 Ordinary shares held in Treasury. Ordinary Shares held in Treasury do not carry any voting rights.
2. Therefore, the total number of voting rights figure that may be used by shareholders as the denominator for the calculations by which they will determine whether they are required to notify their interest in, or a change to their interest in, the Company under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules, is 3,663,040,832.
