The numbers of shares have been calculated using a market price of 376.40 pence per share. For any dividends paid in the period between the grant and release of conditional shares, the number of shares in each case will be increased to reflect the dividends that would have accrued had they been reinvested in shares.

The awards have been granted in respect of the annual deferred bonus for the 2024/25 Financial Year.
