All Ordinary Shares repurchased by the Company under its share repurchase programme are to be held in Treasury. In total, since the Annual General Meeting on 6 March 2024 the Company has repurchased 14,901,358 Ordinary Shares.

Following the purchase, the Company has 130,977,446 Ordinary Shares with voting rights in issue plus 21,696,803 Ordinary Shares held in Treasury.
