## Lion Finance Group PLC announces Transaction in own shares

**Lion Finance Group PLC** (the "Company"- LSE: BGEO LN) announces that on 27 May 2025, Cavendish Capital Markets Limited ("Cavendish") purchased on behalf of the Company the number of ordinary shares of £0.01 each on the London Stock Exchange as set out in the table below (the "Repurchased Shares") pursuant to the share buyback and cancellation programme which was announced on 22 August 2024 and extended on 25 February 2025 (the "Buyback Programme").
