Launch of live beta Al Agent Marketplace and First Agents

Sundae Bar Plc (AIM: SBAR), a company creating a marketplace for Al Agents, today highlights the launch of its live beta Al agent marketplace platform at sundaebar.ai and first agents: Lucy HR Agent, AROK and Marketing Mark. The development of the platform is progressing well with live beta platform being released immediately following the Company's successful admission to AIM on 3 June.

Flagship Al Agents Demonstrate Platform Capabilities

The platform's first three AI agents demonstrate the breadth and sophistication of autonomous AI solutions:

Lucy HR Agent is revolutionising talent acquisition by autonomously managing end-to-end recruiting processes. Trained by top hiring managers, Lucy accesses 300M+ candidate profiles, screens resumes in seconds and, runs personalised outreach to 1,000+ candidates per week. The agent integrates seamlessly with major ATS platforms including Greenhouse, Ashby, and Teamtailor.

AROK is a crypto trading Al agent, functioning as a 24/7 autonomous trading system that is continuously scanning markets on the Solana and Base blockchains. AROK processes social feeds for sentiment analysis and narrative engineering, executing trades on-chain with full transparency and clear fees. Investors gain Al-managed crypto exposure through a non-custodial vault, retaining full control of their wallets.

Marketing Mark serves as a comprehensive marketing digital worker, utilising CMO-level strategy to learn brand identities and autonomously create marketing content. From viral social media scripts to thought-leadership articles, Mark handles instant content ideation, influencer intelligence, trend analysis, and visual content creation, enabling agencies and e-commerce brands to scale marketing efforts without additional headcount.

Showcasing the transformative potential of autonomous Al solutions across critical business operations, the sundaebar.ai platform features a curated directory of Al agents spanning essential business functions. Each agent listing includes comprehensive descriptions, real-world use cases, and clear implementation instructions. The platform currently offers two distinct categories of Al agents:

Immediately Usable Agents: Web-based solutions where users can sign up and immediately begin utilising agent capabilities without technical setup.

Developer-Oriented Agents: Advanced solutions offering implementation code or API endpoints that can be integrated into existing tools and workflows.

The platform prioritises transparency and trust through standardised metadata, visible code links and documentation, and clearly defined capabilities. Users can browse the directory without creating an account, while developers can submit new agents through a structured submission process aligned with the A2A protocol.

Defining the Future of Work

Al agents, software systems capable of autonomously performing complex tasks by designing their own workflows and utilising available tools, represent a fundamental shift in Al applications. Unlike traditional Al tools that require constant human direction, Al agents operate as intelligent teammates, capable of independent decision-making and task execution.

Market Timing and Growth Strategy

The Al agent market is experiencing explosive growth, and according to Statista Market Insight, is projected to reach 47.1 billion by 2030 from 5.1 billion in 2024, representing a compound annual growth rate of 44.8%. With new Al agents being developed at scale, sundae_bar is strategically positioned to enter the market at an optimal inflection point.

Over the coming months, in this pre-launch phase of the full sundae_bar platform, the main focus is on building awareness, generating interest, onboarding early adopters and expanding platform capabilities including, but not limited to:

- Comprehensive agent directory expansion
- Advanced monetisation tools for developers
- Enhanced collaboration features for agent-human workflows
- Enterprise integration solutions

Jill Kenney, Chief Executive Officer of sundae_bar, commented: "sundae_bar's approach fundamentally differs from traditional software marketplaces. Al isn't just a tool anymore. It's becoming a co-worker.
