## **Dividends**

The Board is recommending a 7% increase in the final dividend to 14.12p per share (2024: 13.20p per share). Together with the 9.00p per share interim dividend, this will give a total dividend per share of 23.12p (2024: 21.61p).

The final dividend for the financial year ended 31 March 2025 is subject to approval by shareholders at the Annual General Meeting on 24 July 2025 and, if approved, will be paid on 15 August 2025 to shareholders on the register at 11 July 2025.

The Company offers a Dividend Reinvestment Plan ('DRIP') to enable shareholders to elect to have their cash dividends reinvested in Halma plc shares. Shareholders who wish to opt for the DRIP for the forthcoming final dividend should return a DRIP mandate form to the Company's Registrar no later than 25 July 2025.
