ANNOUNCEMENT ON KEY OPERATING DATA OF MAY 2025

In May 2025, Air China Limited (the "**Company**") and its subsidiaries (the "**Group**") recorded a year-on-year increase in combined passenger traffic (measured by revenue passenger kilometers (the "**RPK**")). Passenger capacity (measured by available seat kilometers (the "**ASK**")) recorded a year-on-year increase of 4.5%, and passenger traffic recorded a year-on-year increase of 8.4%. Among which, for domestic routes, passenger capacity increased by 2.4% year on year, and passenger traffic increased by 6.0% year on year. For international routes, passenger capacity increased by 10.4% year on year, and passenger traffic increased by 16.0% year on year. For regional routes, passenger capacity decreased by 2.6% year on year, and passenger traffic recorded an increase of 0.3% year on year. The passenger load factor was 81.3%, representing an increase of 2.9 percentage points as compared to the same period last year. Among which, the passenger load factor for domestic routes increased by 2.8 percentage

compared to the same period last year. Among which, the passenger load factor for domestic routes increased by 2.6 percentage points year on year, the passenger load factor for international routes increased by 3.7 percentage points year on year, and the passenger load factor for regional routes increased by 2.0 percentage points year on year.

In terms of cargo operations, cargo capacity (measured by available freight tonne kilometers (the "AFTK")) increased by 2.2% year on year. Cargo and mail traffic (measured by revenue freight tonne kilometers (the "RFTK")) increased by 6.2% year on year. The cargo load factor was 41.5%, representing a year-on-year increase of 1.6 percentage points.

Starting from 20 May 2025, the Company added Beijing Capital - Toronto route (two flights per week).

In May 2025, the Group introduced one C919 aircraft and one A320 series aircraft. At the end of May 2025, the Group operated a fleet of 936 aircraft, including 415 self-owned aircraft, 226 aircraft under finance lease and 295 aircraft under operating lease.
