London, 10 July 2025 - Notification of Transactions of Persons Discharging Managerial Responsibilities ("PDMR") and Persons Closely Associated with them ("PCA").

The Company notes that Adobelero Holdings Co. Limited a company owned by Panos Benos, has notified the Company that it has sold 1,600,000 ordinary shares in Energiean (the "**Sale**"), representing approximately 0.87 per cent of the Company's existing issued share capital. The Sale was effected through a private sale to institutional investors.

Mr Benos remains fully committed to the business and is confident in the outlook for Energiean. Following completion of the Sale, Mr Benos will remain a significant shareholder in Energiean owning (directly or indirectly) approximately 2.35 million ordinary shares of the Company, representing approximately 1.28 % of the Company's issued share capital.
