Man Group plc (the "Company"), announces that it has purchased the following number of its ordinary shares of 3 3/7 US cents as part of its US 100 million share buyback programme announced on 28 February 2025.

The Company intends to hold the purchased shares in treasury. Following the purchase and settlement of these shares, the Company will hold 106,565,989 of its ordinary shares in treasury and will have 1,167,383,471 ordinary shares in issue (excluding treasury shares).

Since the commencement of the share repurchase programme, the Company has repurchased 24,332,226 ordinary shares in aggregate at a weighted average price of 184.75 pence per share.
