Bakkavor completes sale of its China operations, concluding the Group's exit from the region

Further to the announcement on 29 April 2025, Bakkavor Group plc ("Bakkavor" or "the Group") today confirms that it has completed the sale of its China operations (Bakkavor China Holdings Limited) to Lihe Xing (Qingdoa) Food Technology Co. Ltd., wholly owned by Lihoo's (Qingdao) Food Industry Company Limited ("Lihoo's").

The cash consideration is RMB 509m¹ (c.£50m) on a cash and debt-free basis. At 28 June 2025, the carrying value of net assets of the China operations is expected to be c.£32m, resulting in an expected net profit on disposal of at least c.£18m, following completion adjustments. Transaction proceeds will be used to further reduce the Group's leverage.

This sale completes the Group's successful exit from the region and supports the delivery of the Group's medium-term margin target of 6%.

Mike Edwards, CEO, commented:

"After more than two decades in China, we are incredibly proud of the business we have built and I would like to thank our colleagues for their contribution, and for their commitment in continuing to deliver excellent service for our customers throughout this process. We are confident of the business's continued success under Lihoo's ownership, benefitting from their local expertise as it embarks on the next phase of its growth journey.

The Group's strategy remains clear, and the exit from China enables us to sharpen our focus on our core business and support the delivery of our medium-term margin target.
