Standard Chartered PLC ("**SC**") announces that on 30 July 2025 it purchased the following number of its ordinary shares of US 0.50 each from J.P. Morgan Securities plc pursuant to the share buy-back programme previously detailed in the announcement of 24 February 2025 (the "**Buy-back**").

As at close of business London time on the trading day preceding the date of this announcement, SC had applied an aggregate of US 1,489,055,532.39 to share purchases pursuant to the Buy-back.

Following the purchase of these shares, the Buy-back that commenced on 25 February 2025 (announced on 24 February 2025), has completed. Since the commencement of the Buy-back, the Company has repurchased for cancellation 98,162,451 ordinary shares at a volume weighted average price of £11.5478 per ordinary share for an aggregate consideration of approximately US 1,499,999,886.98.

SC intends to cancel the purchased shares. Following the cancellation of the purchased shares, SC will have 2,316,065,052 ordinary shares in issue. Therefore, the total number of voting rights in SC will be 2,316,065,052.

Any such share purchases will be effected in accordance with certain pre-set parameters and limits, and in accordance with applicable law and regulation as described in more detail in SC's announcement of 24 February 2025.

In accordance with Article 5(1)(b) of Regulation (EU) No. 596/2014 (as incorporated into UK domestic law by the European Union (Withdrawal) Act 2018), a full breakdown of the individual trades is attached to this announcement.
