WRAP Retail Offer for up to £50,000

Sunrise Resources plc (AIM: SRES) is pleased to announce a retail offer via the Winterflood Retail Access Platform ("WRAP") to raise up to £50,000 (the "WRAP Retail Offer") through the issue of new ordinary shares of 0.001p each in the capital of the Company ("Ordinary Shares"). Under the WRAP Retail Offer up to 294,117,647 new Ordinary Shares (the "WRAP Retail Offer Shares") will be made available at a price of 0.017 pence per share.

In addition to the WRAP Retail Offer and as announced on 31 July at 7.00am, the Company has made a conditional placing of new Ordinary Shares to raise £200,000 (before expenses) (the "Placing") at a price of 0.017 pence per Placing Share (the "Placing Price"). The Placing Price represents a discount of approximately 17.1 per cent. to the mid-market closing price of an Ordinary Share on 30 July 2025 (being the latest practicable date prior to this announcement). The issue price of the WRAP Retail Offer Shares is equal to the Placing Price.

A separate announcement has been made regarding the Placing and its terms and sets out the reasons for the Placing and use of proceeds. The proceeds of the WRAP Retail Offer will be utilised in the same way as the proceeds of the Placing.

For the avoidance of doubt, the WRAP Retail Offer is not part of the Placing. Completion of the WRAP Retail Offer is conditional, *inter alia*, upon the completion of the Placing but completion of the Placing is not conditional on the completion of the WRAP Retail Offer.

The WRAP Retail Offer is conditional on the New Ordinary Shares being admitted to trading on AIM (*Admission*). It is anticipated that Admission will become effective and that dealings in the New Ordinary Shares, which will rank *pari passu* with all existing ordinary shares, will commence on AIM, on or around Wednesday 6 August 2025.

WRAP Retail Offer

The Company values its retail shareholder base and believes that it is appropriate to provide its existing retail shareholders in the United Kingdom the opportunity to participate in the WRAP Retail Offer.

Therefore, the Company is making the WRAP Retail Offer open to eligible investors in the United Kingdom, being existing shareholders of Sunrise Resources plc, following release of this announcement and through certain financial intermediaries.

The WRAP Retail Offer is expected to close at 10.00am on Friday 1 August 2025. Eligible shareholders should note that financial intermediaries may have earlier closing times.
