This disclosure is to reflect the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("aI(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("aIML") increased above the 57% notifiable threshold due to a change in voting rights on 06 August 2025. aI(H)L now effectively holds and aIML holds the delegated voting rights to 57.017301% of the shares in Patria Private Equity Trust PLC. Prior to this crossing, aI(H)L effectively held and aIML held 56.998178% of the delegated voting rights.
