The Company intends to cancel the purchased shares. Following the cancellation of the purchased shares, the Company will hold 57,277,027 of its ordinary shares in treasury and have 677,640,907 ordinary shares in issue (excluding treasury shares).

Therefore, the total number of voting rights in the Company will be 677,640,907 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
