The redemptions form part of Flutter's intention to buy back Ordinary Shares of up to 225 million in the period to September 30, 2025 following the announcement of the share buyback program on May 8, 2025 (the "Buyback") and form part of Flutter's intention to buy back 5 billion of shares as announced on September 25, 2024. The acquisitions were effected by Flutter's broker Davy Securities.

Following settlement of the above transactions and the subsequent cancellation of shares, Flutter will have 175,837,032 Ordinary Shares in issue.
