Following settlement of this purchase on 08 September 2025 the issued share capital of the Company will be 95,050,253 Ordinary Shares, excluding 22,878,685 shares which are held in treasury. Å Shares held in treasury do not carry any voting rights; 19.4% of the Companyâ€™™s total issued share capital (117,928,938 Ordinary Shares, including treasury shares) will be held in treasury following settlement.

For reporting purposes under the FCA's Disclosure Guidance and Transparency Rules the market should exclude any shares held in treasury and should use the figure of 95,050,253 following settlement when determining if they are required to notify their interest in, or a change to their interest in the Company.
