

### Transactions in own Shares

Man Group plc (the "Company"), announces that it has purchased the following number of its ordinary shares of 3 3/7 US cents as part of its US 100 million share buyback programme announced on 28 February 2025.

The Company intends to hold the purchased shares in treasury. Following the purchase and settlement of these shares, the Company will hold 70,005,930 of its ordinary shares in treasury and will have 1,159,355,299 ordinary shares in issue (excluding treasury shares). Note: This figure takes into account the transfer from treasury of 523,117 ordinary shares on 12 September 2025 in order to satisfy awards made under the Company's Partner Share Plans.

Since the commencement of the share repurchase programme, the Company has repurchased 32,883,515 ordinary shares in aggregate at a weighted average price of 180.29 pence per share.
