Reckitt Benckiser Group plc (the "**Company**") announces today it has purchased the following number of its ordinary shares of 10 pence each ("**shares**") from RBC Europe Limited ("**RBC**") in accordance with the authority granted by shareholders at the Company's Annual General Meeting on 8 May 2025 (the "**Purchase**"). Therefore, the total number of voting rights in the Company will be 675,967,087 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
