**Transaction in Own Shares**

Touchstar plc (AIM: TST), suppliers of mobile data computing solutions and managed services to a variety of industrial sectors, announces that it purchased 6,563 ordinary shares of £0.05 each in the Company (the "Repurchased Shares"), pursuant to the share buyback programme (the "Buyback Programme") that was announced on 24 June 2025, as follows (together the "Transaction"):

**Total Voting Rights**

Following the Transaction, the issued share capital of the Company remains unchanged at 8,475,077 and the Company now holds 336,849 shares in treasury. The total voting rights in the Company is now 8,138,228 which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Touchstar plc under the FCA's Disclosure Guidance and Transparency Rules.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.
