His personal investment in Sagebrush and his long-standing commitment to Mosman since 2017 make him the ideal person to lead the Company. Over the coming months we will reach important milestones, including the start of 3D seismic over Sagebrush in October and the extended well test on Sagebrush-1 in Q4. Together with progress at Coyote Wash, these steps mark the beginning of an exciting new chapter for Mosman. With an independently verified helium resource and a clear pathway to development, the Company is well positioned for future value creation and we move forward with confidence."
