### **Publication of Final Terms**

The Final Terms dated 1 October 2025 relating to the issuance by Diageo Finance plc ("**the Issuer**") of (i) EUR 500,000,000 3.250% Fixed Rate Instruments due 3 October 2032, and (ii) EUR 500,000,000 3.750% Fixed Rate Instruments due 3 October 2037 (together the "**Instruments**"), guaranteed by Diageo plc (the "**Guarantor**") are available for viewing.

The Instruments have been issued under the European Debt Issuance Programme established by the Issuer and the Guarantor (the "**Programme**").

The Final Terms should be read and construed in conjunction with the base prospectus dated 20 August 2025 in relation to the Programme (the "**Base Prospectus**").
