CANAL+ SA (LSE: CAN, the "**Company**"), the global media and entertainment company, announces that on 07 October 2025 it had purchased a total of 174,934 of its ordinary shares of €0.25 each (the "**Ordinary Shares**"), through the Company's broker Natixis, as detailed below. The repurchased Ordinary Shares will be held in treasury for the purposes of satisfying share awards to employees and corporate officers made under its share-based incentive plans.

1,542,838 Ordinary Shares are held in treasury. Therefore, the total number of voting rights in the Company is 990,416,656.
