#### **Secondary Share Placement & Director/PDMR Shareholding**

Pulsar Helium Inc. (AIM: PLSR, TSXV: PLSR, OTCQB: PSRHF) ("Pulsar" or the "Company"), the helium project development company, notifies the disposition on October 27, 2025, of 8,223,684 common shares in the Company ("Common Shares") controlled by ABCrescent Cooperatief U.A. ("ABC"), a company of which Brice Laurent, a Director of the Company, is a managing partner (the "Disposition"). ABC advises that 8,223,684 Common Shares were sold in the UK at a price of 0.38 pence for aggregate proceeds of approximately £3,125,000.

ABC advises that following the Disposition: (a) ABC exercises control or direction over, directly or indirectly, 7,276,316 Common Shares, representing 4.81% of the Company's issued and outstanding Common Shares, and 15,500,000 Warrants; and (b) assuming the exercise in full of the Warrants, ABC would exercise control or direction over, directly or indirectly 22,776,316 Common Shares, representing approximately 13.65% of Pulsar's outstanding Common Shares on a partially diluted basis.

In addition, Pulsar notes that Brice Laurent is interested directly in 450,000 stock options held over Common Shares under the Company's shareholder-approved Stock Option Plan. Mr. Laurent also reports that he personally holds 17,570 Common Shares.
