GEM DIAMONDS LIMITED Q3 2025 Trading Update

Gem Diamonds Limited (LSE: GEMD) ("**Gem Diamonds**" or the "**Company**" or the "**Group**") provides the following trading update detailing the Group's operational and sales performance from 1 July 2025 to 30 September 2025 ("**Q3 2025**" or the "**Period**").

Highlights:

- Carats recovered during the Period were 22 268 (Q2 2025: 23 547).
- Three greater than 100 carat diamonds were recovered during the Period and a 319 carat diamond was recovered after the Period, bringing the total year to date recoveries of greater than 100 carat diamonds to eight.
- 22 830 carats were sold during the Period (Q2 2025: 23 932 carats), generating revenue of US 25.7 million (Q2 2025: US 23.5 million) and achieving an average price of US 1 124 per carat (Q2 2025: US 980 per carat).
- Four greater than 100 carat diamonds were sold during the Period.
- Two diamonds sold for more than US 1.0 million each, contributing US 2.3 million to revenue for the Period.
- The highest price achieved in the Period was US 33 785 per carat for a 32.01 carat white diamond.
- All operational and financial metrics are trending within the revised guidance issued for 2025, as disclosed in the Company's H1 2025 Trading Update.
- The decisive measures to conserve cash as previously reported have been completed, with the anticipated c.US 1.5 million monthly savings being realised from September 2025.
