Therefore, the total number of voting rights in the Company will be 8,411,714,630 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

Since the commencement of the Programme, the Company has repurchased 93,182,359 Ordinary Shares in aggregate at a weighted average price of 917.7389 pence per Ordinary Share.
