This disclosure reflects the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("al(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("alML") increased above the 5% notifiable threshold due to trading on 14 November 2025. al(H)L effectively holds and alML holds delegated voting rights to 5.017763% of the shares in Robert Walters PLC.
