The Purchase was effected pursuant to instructions issued by the Company on 25 September 2025, as announced on 26 September 2025. The repurchased shares will be held in treasury.

Following the above transaction, the Company will hold 58,397,838 of its ordinary shares in treasury and have 673,691,501 ordinary shares in issue (excluding treasury shares).

Therefore, the total number of voting rights in the Company will be 673,691,501 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
