CANAL+ SA (LSE: CAN, the "Company"), the global media and entertainment company, announces that on 25 November 2025 it had purchased a total of 14,908 of its ordinary shares of €0.25 each (the "Ordinary Shares"), through the Company's broker Natixis, as detailed below. The repurchased Ordinary Shares will be held in treasury for the purposes of satisfying share awards to employees and corporate officers made under its share-based incentive plans.

The purchases form part of the Company's Share Buyback Programme announced on 24 September 2025. In respect of this programme, Natixis will make trading decisions in relation to the securities independently of the Company in the period from 25 September 2025 up to 19 December 2025.

10,568,156 Ordinary Shares are held in treasury. Therefore, the total number of voting rights in the Company is 981,391,338.
