This disclosure reflects the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("al(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("alML") increased above the 5% notifiable threshold due to an event changing the breakdown of voting rights on 26 November 2025. al(H)L now effectively holds and alML holds the delegated voting rights to 5.000934% of the shares in Hunting PLC.
